- To be valid, this proxy form together with any power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority, must be deposited with the Company at 5th Floor, Longfu Mansion, No. 95 Longfusi Road, Dongcheng District, Beijing, the People's Republic of China not less than 24 hours before the time appointed for holding the Domestic Share Class Meeting (i.e. no later than 10:30 a.m. (Hong Kong time) on 27 November 2025) or any adjournment thereof (as the case may be).
- In the case of joint holders, the vote of the senior, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holder(s). For this purpose, seniority is determined by the order in which the names stand in the register of members in respect of the joint holding.
- Completion and delivery of this proxy form will not preclude you from attending and voting at the Domestic Share Class Meeting or any adjournment thereof if you so wish.
